Executive Committee of “The 1st International Open Remote Competition”

Implementation Guidelines of
The 1st International Sport Wellness Fukiya Open Remote Competition

Purpose:

General Incorporated Association “Japan Sport Wellness Fukiya Association” (hereinafter referred to as “The Association”) will hold “The 1st International Sport Wellness Fukiya Open Remote Competition” (hereinafter referred to as “International Open Remote Competition” or “Remote Competition”) targeting all members of The Association (including overseas members) in order to raise the morale of members by designating each practice site of branches (including overseas branches) as the scattering competition sites (hereinafter referred to “Remote Competition Sites”). Competition shall be done within the prescribed period and all results shall be aggregated and Executive Committee shall decide the ranking of each competition class.

Final result shall be announced in Website of The Association.

When executing this International Open Remote Competition, it must be carried out fairly and justly as much as possible and we shall increase the sense of unity and mutual communication with Sport Wellness Fukiya companions in the world.

1. Implementation Period:

10th May (Monday) through 5th June (Saturday) 2021

Contestants shall participate during this period at each “Remote Competition Site”.

2. Outline of executing International Open Remote Competition:

(1) Qualification for participation::

All members of The Association are qualified to participate.

(2) Securing the venue:

Branches who wish to participate must secure the Remote Competition Site during the implementation period. Ordinary practice sites can be acceptable.

In case unable to hold in one time, the plural dates and sites can be acceptable.

(3) Pre-application:

Branches who wish to participate shall apply in advance to the secretariat of the Executive Committee (hereinafter referred to as “Secretariat”), mentioning

Remote Competition Site, Date and Time, Name of Participants.

In case of overseas branches, please send pre-application to Mr. Kazuya (Kenny) Ito kazuyaito0202215@yahoo.co.jp General Manager for International Operations

No participation fee is necessary.

(4) Venue:

Each branch shall prepare Remote Competition Site.

(5) Executive committee chairperson:

Each branch shall appoint executive committee chairpersons (main & sub). Executive committee chairpersons (main & sub) shall be responsible for the proceedings of competition and scoring.

(6) Executing competition:

Participants shall follow the instruction of chairpersons and shall “blow five darts for a round and play six rounds” in accordance with The Association’s Rules and Regulations about Competitions.

(7) Referees:

Executive committee chairpersons shall appoint referees who are not the contestants of the 1st through 6th rounds concerned.

(8) Confirmation of Scores:

Scoring shall be performed after each round by referees and referees shall record the scores on the scoring sheet of each contestant. Any question arising as to the scoring, the chairperson shall make rulings.

(9) Scoring and tallying up:

After completing each round, each participant’s score shall be recorded and added up.

(10) Reporting the result:

After executing all rounds, executive committee chairperson shall report scores of each participant to the Secretariat.

(11) Tally up the scores:

Secretariat shall tally up the scores for each competition classification.

(12) An announcement of the result:

The result shall be announced in the Website of Japan Sport Wellness Fukiya Association. Prizes shall be given to the winners.

3. Remote Competition site and implementation period:

Branches which will prepare Remote Competition Site shall apply the following items in advance;

- (1) Name of the Remote Competition Site, and its address,
- (2) Number of lanes can be installed.
- (3) Scheduled date (shall be during 10th May through 5th June)
- (4) Scheduled time (for example, 10:00 – 15:00)
- (5) Name of participants (to be limited for completing six rounds each in scheduled time mentioned above)
- (6) Availability of Internet connection (Wi-Fi) at Remote Competition Site

Remarks:

- ① Even if members group is not yet registered as an overseas branch, members group can participate in this Open Remote Competition by applying above (1) through (6) in advance, if they can secure the Site..
- ② If Remote Competition Site is not secured during the pre-application period, application form mentioning only scheduled date can be acceptable.
- ③ In case Internet connection (Wi-Fi) is available at Remote Competition Site, such branches can participate in On-line Opening Ceremony to be held at the head office of The Association.

4. Pre-application period:

1st April (Thursday) through 30th April (Friday) 2021

6. Competition classification (distance) and entry qualification:

- 10mA class: Ordinary 5th Dan-I or higher grade holder
- 10mB class: Junior 4th Dan-I or higher, Ordinary 3rd and 4th Dan-I grade holder
- 9m class: Junior 3rd Dan-I, Ordinary 2nd Dan-I grade holder
- G8m class: Ordinary 1st Dan-I or higher grade holder and older than 80 years old who wishes to play in 8m distance

- 8m class: Junior 2nd Dan-I, Ordinary 1st Dan-I grade holder
- 7m class: Junior 1st Dan-I, Ordinary 1st Kyu-I grade holder
- 6m class: Junior 1st Kyu-I, Ordinary 2nd Kyu-I and lower grade holder, including ordinary members without any Kyu-I grade
- 6mN class: Members who affiliated The Association on or after 1st February 2021
- 5m class: Junior 2nd Kyu-I grade holder
- 4m class: Junior 3rd Kyu-I or lower grade holder, including Junior members without any Kyu-I grade

Remarks:

- ① Members who wish to play in lower class than the grade obtained for health reasons, an approval from Executive committee chairperson shall be necessary.
- ② Nobody can participate in higher class than the grade obtained.

7. Competition rules:

Rules and Regulations about Competition of The Association shall be applied.

- (1) Participants shall blow five darts for a round and play six rounds.
- (2) Participants shall follow the Basic Motions of Sport Wellness Fukiya.
- (3) Ranking shall be decided by each competition class (refer to above **6.**)

8. Executive committee chairpersons (main & sub):

- (1) Executive committee chairpersons (main & sub) shall be Branch General Manager or persons in charge of branch management.
- (2) Executive committee chairpersons are able to participate in Remote Competition, but either main or sub chairperson shall execute the duties of chairperson in the rounds concerned.

9. Competition Referees:

- (1) Executive committee chairperson shall appoint competition referees from Certified Referees, Certified Instructors or Branch Directors.
- (2) Competition referees shall dedicate themselves to refereeing the round concerned (1st through 6th round)
- (3) Scoring shall be performed after each round by referees and referees shall record the scores on the scoring sheet of each contestant and report to executive committee.
- (4) Any question arising as to the scoring, the chairperson shall make rulings.

(5) Scoring and adding up:

- ① Scores reported by competition referees shall be recorded and added up.
- ② Executive committee chairperson shall check and confirm the scores.

10. Reporting the result:

Executive committee chairpersons shall report the result without any delay after completing Remote competition (by next day or day after next) to:

11. Determination of the Ranks:

Executive Committee of The Association shall execute the following procedures:

- (1) Tally up the scores for each competition classification and ranks shall be determined from the highest scores of total rounds to the next in the order.
- (2) In case of same total scores in same competition class:
 - ① Contestant who has more 35points-rounds shall become higher rank.
 - ② In case same number of 35points-rounds, contestant who has a higher score of 6th round shall become higher rank, then we compare 5th round, 4th round in the order.
 - ③ In case same scores for above comparison, lower Dan-I/Kyu-I grade holder shall become higher rank, but no grade holder shall become lower rank.
 - ④ In case of same scores and Dan-I/Kyu-I grade for above comparison, bigger member number holder becomes higher rank.

12. An announcement of the result:

The result shall be announced in the Website of Japan Sport Wellness Fukiya Association. Public Relations Department shall report the result in the Website based on the tally sheet made by Competition Department.

13. Prize-giving:

Winner, the runner-up, 3rd place and each 50th rank, such as 50th, 100th, and 150th and so on will be awarded.

Award shall be the gift certificate for the official equipment (Winner will have Yen5.000-certificate and others Yen3.000-certificate).
